## TERMS AND CONDITIONS

# General

- Lucratunity does not guarantee any success with its services, business plans or anything else we offer.
- Success rate is completely up to members.
- We offer services to our customers in return for a monthly fee and partial ownership of their business/company/venture.
- Approved members that take part in our networking program are in a sense hired contractors where as Lucratunity LLC is not liable for their actions.
- Rules that our members set for their own companies have nothing to do with Lucratunity LLC.
- The member is fully liable for the breaking of contract between Lucratunity LLC and the member.
- Lucratunity LLC has the right to refuse further service to members that violate our rules.
- Lucratunity LLC has the right to refuse doing business with customers with business ideas of their own that do not promote Lucratunity's image in a positive way.
- Lucratunity owns 10% of companies that where established on ideas of the member and 20% of companies that where established on ideas of Lucratunity.
- Ownership for Lucratunity LLC means the percentage of ownership belonging to Lucratunity LLC is taken from the total profits before expenses of the company/business/venture belonging to the member.
- Members that sign up, do not own any part of Lucratunity LLC.
- Lucratunity is only the receiver of percentage from profit and not debt that the member's company/business/venture earns.
- The percentage of ownership that Lucratunity owns will remain until the company/business/venture goes bankrupt or if Lucratunity decides to sell its ownership or buy out its member by increasing ownership percentage.
- Other companies may not implement our business concept in their company.
- Services Lucratunity provides such as but not limited to: logo creation, name creation, advertising are not what the members pay for and are free services we offer to our members.
- Members pay for their right to use our business plans/ventures.

# Memberships

- Members agree to pay the monthly fee of their membership.
- There will be no refunds, all sales are final.
- Members are fully aware of what they pay for when they sign up with Lucratunity LLC.
- Members will not do anything to harm Lucratunity LLC in any way.

# Business plans

- All members taking part in business ventures with Lucratunity LLC must state their total revenue each month for entitled percentages owed to Lucratunity LLC.
- Business plans (ventures) that we create for our members.
- Some business plans are limited to one each month.
- Members allow Lucratunity LLC to promote the member's company/business/venture in any way and allows Lucratunity LLC to say anything about said company/business/venture with member being fully liable.
- Members will have the choice of one business plan every month depending on the size of the venture.
- Business ventures that require a large start up budget will be unlocked once proof that member can afford the venture is given to Lucratunity LLC.

# Patenting

- All patenting done by Lucratunity upon request will be a poor man's patent, Lucratunity LLC does not guarantee the patent will hold up in court.
- Lucratunity is not officially licensed to provide its members with any other form of patents than poor man's patents.
- Members are fully aware that Lucratunity is not liable for anything negative results resulting from its poor man's patenting.

# Payments

- Members agree to pay membership fees, and any additional charges that may arise.
- Membership fees are due every month from when a member signs up.
- Memberships will be immediately terminated if membership is not paid in full and on time, this does not affect the ownership Lucratunity LLC has of any company/business/venture it partially owns.
- Membership fees will consistently need to be paid in full for agreed upon duration of membership, if duration of membership is set to indefinite, monthly payments will be set for auto renewal and need to be paid in full to Lucratunity LLC until membership is canceled by member or by Lucratunity LLC.

- We are not liable for anything negative that may be the result of the services we offer to our members.
- Advice we give are only suggestions members choose to follow at their own risk.
- Any services other than the business ventures we offer are complimentary to members and should be appreciated as such.
